The Authority undertook extensive flushing, pre-chlorination control, rerouted the return water line to Lake Durango, cycled storage tanks levels and maintained a high reservoir level which resulted in no TTHM violations in 2019. The Authority is currently working with an engineering firm to develop a long-term solution to the formation of distribution by-products. A compliance report and system evaluation was submitted to CDPHE in January 2020. The Authority is now doing additional analysis to determine the most cost effective method for TTHM control.
